Imagine a largely tax-free state—a state with no income tax, a state where an Illinoisan can move and lower his or her overall income tax rate by at least 10%. Like most other states, this state also has no estate tax, perhaps reducing a person's estate tax bill by 20%, or even 100%.

It is fascinating and astounding that Illinois, Cook County, and Chicago took top (dis)honors in all three categories. Is it any wonder that Illinois loses a resident every 5 minutes and about \$1,000 of taxable income every minute? Two out of three moves involving Illinois are outbound and those new folks moving to Illinois make materially less than those earners leaving the state.

The *Chicago Tribune* reported that in 2016 Chicago lost more millionaires than any other city on Planet Earth, with the exception of Rome and Paris. Future Illinois income tax increases, which are a virtual certainty, will only worsen the current situation.
